This is to inform that the PC Sharma Eye Hospital, Ambala City (Haryana) has agreed to provide the following concessions to BBMB employees/pensioners/family pensioners and their dependents: -

#### **OPD Services:**

The hospital offers rates for OPD as per CGHS (NABH) Chandigarh 2014 and 20% discount on non-listed procedures/investigations on current hospital schedule of charges.

#### **IPD Services:**

The hospital offers rates of IPD as per CGHS (NABH) Chandigarh 2014 and 20% discount on Non listed Procedures/Surgeries on current hospital Schedule of charges.

\*\*\* Applicable tariff of hospital is CGHS (NABH) Chandigarh Rates 2014, for rest procedures/investigations/Surgeries/IPD/OPD 20% Discount on current hospital SOC.

The Concessions given by the Hospital are subject to the following conditions: -

- I. BBMB will sign no agreement with the Hospital in this regard and shall never act as party in any concern/issue between the employee/pensioner etc. and hospital at any stage of time. The matter shall rest between the employee/pensioner etc. acting as their direct consumer and respective hospital.
- II. BBMB will not be liable for any payment to hospital in lieu of treatment taken by any officer/official BBMB henceforth.
- III. The employees would require making payment directly to the hospital authorities.

- IV. The offers as given by hospital will be applicable on BBMB employees having valid ID cards/family members/pensioners (including family pensioners) having valid PPO as per the requirement of respective hospital.
- V. BBMB will not be liable for any financial/legal complications if arise in any case as per point (I) above.
- VI. The beneficiaries i.e. BBMB employees having valid ID cards/family members/pensioners including family pensioners be advised to have full knowledge of hospital rules/rates (CGHS/Discounted rates)/conditions before availing services as BBMB will not be liable or responsible to give any clarification or attend any complaint in this regard.
- VII. BBMB will not bound any of its employees/their family members/pensioners and family pensioners to get the treatment from their hospital.
- VIII. Payment of OPD and IPD will be made directly to the hospital by the BBMB employees/family members/pensioners and family pensioners. However, the BBMB employees/family members/pensioners including family pensioners, if entitled to get reimbursement, can claim re-imburement from BBMB as per prevailing instructions/rules.
- IX. No PAN/TAN/GST No. shall be provided by BBMB to the hospital for any intent and purposes.
